

## Privacy policy pursuant to EU Reg. 2016/679 (GDPR)

Your personal data will be collected and processed by Rhein 83 S.r.l. Your personal data collected through this form will be processed for the following purposes:

- 1. Management of registration and participation in the initiative in question.** The legal basis is the execution of contractual or pre-contractual measures requested by the user (registration for the event). - 2.
